Dear Sir,

This is in reference to the Discussions between Mr. Jeff Sheridan working from your office and this committee concerning Rule 28 - Signal Inspectors, particularly paragraph (b), and Appendix "M" of the Agreement covering employees working on the B&O Railroad Property, as amended.

The discussions involved the distribution and proportion of Signal Inspectors on each of the existing seniority districts, the apportionment of Signal Inspector positions to each seniority district, and the seniority district(s) referred to in Rule 28 (f).

It is hereby agreed to modify Rule 28 (b) as follows:

- (a) The seventeen (17) positions of Signal Inspector, or any number of Signal Inspector positions as may be maintained from time to time based on requirements of the service, in the judgment of the Management, shall be governed by this Rule 28.

(b) The positions of Signal Inspectors will be distributed, and the proportion maintained, as follows:
